

EXTERNAL MERCHANDISE TRADE STATISTICS

DECEMBER 2016

- In December 2016, merchandise export and import amounted to MOP753 million and MOP6.78 billion respectively, down by 16.1% and 2.9% respectively year-on-year. Merchandise trade deficit totalled MOP6.03 billion.
- In the fourth quarter, merchandise export and import totalled MOP2.31 billion and MOP19.61 billion, down by 8.7% and 7.3% respectively year-on-year, resulting in a trade deficit of MOP17.30 billion.
- For the whole year of 2016, merchandise export dropped by 6.0% year-on-year, of which re-exports decreased by 8.9% but domestic exports increased by 7.8%; merchandise import declined by 15.7%. External merchandise trade decreased by 14.6% year-on-year to MOP81.40 billion. Merchandise trade deficit reached MOP61.31 billion.
- For the whole year of 2016, merchandise export to Mainland China dropped by 4.7% year-on-year to MOP1.75 billion, of which exports to the nine provinces of the Pan Pearl River Delta (MOP1.64 billion) fell by 7.4%. Analysed by place of consignment, merchandise import from Mainland China slid by 5.3% to MOP12.02 billion, of which imports from the nine provinces of the Pan Pearl River Delta (MOP11.35 billion) fell by 6.4%.




Total external trade and exports/imports ratio
