

## EXTERNAL MERCHANDISE TRADE STATISTICS

### **JUNE 2016**

- Merchandise export and import amounted to MOP821 million and MOP5.71 billion respectively, down by 11.5% and 14.6% respectively year-on-year. Merchandise trade deficit totalled MOP4.89 billion.
- In the second quarter, merchandise export and import totalled MOP2.41 billion and MOP16.60 billion, down by 12.7% and 18.5% respectively year-on-year, resulting in a trade deficit of MOP14.19 billion.
- In the first half year of 2016, merchandise export fell by 6.5% year-on-year; domestic exports and re-exports declined by 10.4% and 5.7% respectively; merchandise import dropped by 21.1%. External merchandise trade decreased by 19.4% year-on-year to MOP38.71 billion. Merchandise trade deficit widened further to MOP28.50 billion.
- Merchandise export to Mainland China grew by 4.1% year-on-year to MOP890 million in the first half year of 2016, of which exports to the nine provinces of the Pan Pearl River Delta (MOP844 million) rose by 2.4%. Analysed by place of consignment, merchandise import from Mainland China fell by 9.2% to MOP5.58 billion, of which imports from the nine provinces of the Pan Pearl River Delta (MOP5.31 billion) declined by 9.2%.






#### Total external trade and exports/imports ratio
