


3RD QUARTER 2020


- A total of 63 MICE events were held, comprising 53 meetings & conferences and 10 exhibitions. Number of participants & attendees totalled 297,000. In the first three quarters of 2020, a total of 215 MICE events were held, with 399,000 participants & attendees.
- Number of meetings & conferences dropped by 267 year-on-year, and number of participants (3,428) declined by 93.9%; the average duration of the meetings & conferences shortened by 0.8 day year-on-year to 0.7 day. In the first three quarters, there were 198 meetings & conferences, a drop of 829 year-on-year, with number of participants falling by 88.7% to 22,000; the average duration of the meetings & conferences reduced by 0.4 day to 1.1 days.
- Number of exhibitions went down by 7 year-on-year, and number of attendees (294,000) dropped by 44.1%; the average duration of the exhibitions extended by 0.1 day to 3.6 days. In the first three quarters, exhibitions decreased by 22 year-on-year to 15, with number of attendees (376,000) declining by 64.5%; the average duration of the exhibitions remained at 3.4 days.
- The 10 exhibitions in the third quarter were all held by non-government organisations, and receipts of these exhibitions amounted to MOP 7.64 million. After deducting expenditure (MOP 7.99 million) as well as financial support from the government & other organisations (MOP 1.19 million) from receipts, a negative value of MOP 1.53 million was recorded. In the first three quarters, receipts of the 15 exhibitions held by non-government organisations totalled MOP 14.23 million. After deducting expenditure (MOP 12.97 million) and financial support from the government & other organisations (MOP 2.08 million) from receipts, these exhibitions recorded a negative value of MOP 0.82 million.

















Receipts and Expenditure of Exhibitions Held by Non-Government Organisations




Note: "Others" includes remuneration for staff who assisted in the exhibitions, service charges for companies providing conference & exhibition organising services, food & beverages, security services, etc.








Receipts and Expenditure of Interviewed Exhibitors

Scope and Coverage:

MICE Statistics covers meetings & conferences, commercial exhibitions and incentives that are held in paid venues, such as hotels and major convention & exhibition centres in Macao. However, meetings with less than 10 participants; meetings for product launch, orientation and press conference; as well as exhibitions not involving business activities, e.g. photo, painting and other cultural & art exhibitions, are excluded.

Glossary:

Government Meeting¹: An event at which attendees are civil servants, government officials or service providers to governmental entities, with the aim of discussing topics or reaching agreements.

Association Meeting: An event initiated by an association.

- Corporate Meeting1: Gathering of employees or representatives of a commercial organisation. Usually, travel, accommodation and meal expenses of the attendees are paid for by the organisation.
- An event where the attendees meet to exchange views, convey a message, open a debate or give publicity to some area of opinion on specific Conference: issues. Usually, a conference is divided into sessions based on various areas relevant to the conference theme.

Commercial Exhibition¹ includes events where:

- a) Exhibitors display goods and services of one or more industries. These events focus primarily on business-to-business relationship. The primary activity of attendees is to visit exhibits on the show floor;
- Exhibitors display, promote and/or sell goods of one or more industries to public consumers. b)

An incentive may include various sessions, of which meetings are an essential part of the event.
