

- A total of 1,095 new companies were incorporated in the first quarter, a decrease of 422 year-on-year. Meanwhile, total value of registered capital soared by 6,063.3% to MOP13.51 billion.
- In terms of origin of capital, mainland China contributed MOP13.40 billion (99.1% of total) to the capital of newly incorporated companies, with MOP13.01 billion coming from Beijing. Capital from the Mainland cities in the Greater Bay Area totalled MOP47 million, of which Zhuhai accounted for 69.5%. Moreover, capital from Macao and Hong Kong stood at MOP81 million and MOP35 million respectively.
- Companies in dissolution totalled 208 and the value of registered capital of these companies amounted to MOP49 million. At the end of the first quarter, total number of registered companies was 81,942.






### Newly incorporated companies and companies in dissolution
